Section A: Letters of Explanation/Support. This form must be accompanied by the following:

First-time request at the University of Akron:

A signed and detailed letter from you, the student, explaining the extenuating circumstance, including your relationship with both biological/adoptive parents.

A separate letter from an independent third party source (ie. counselor, medical authority, clergy, court, government agency) who can attest firsthand to the extenuating circumstances. This letter must be signed and detailed with as much information about the situation as possible.

Request for renewal for previously approved dependency appeal at the University of Akron:

A new, signed statement indicating your relationship status with your biological/adoptive parents.

Section B: Financial Documentation ALL documentation is required before your request can be reviewed.

Your 2012 Federal Tax Return Transcript or successful use of the Data Retrieval Tool (see [www.uakron.edu/finaid/taxinfo](http://www.uakron.edu/finaid/taxinfo) for guidance)

Your 2012 W2(s) - only submit if you were not required to file a 2012 federal tax return with the IRS

If you did not work/are not working, provide a statement about how you are supported (expenses such as medical, car, etc.) and by whom those expenses are paid. Include a statement that you did not/were not required to file a tax return in 2012.
